

Community Sponsorship Agreement

This Agreement was made on the _____ day, in the Month of _____, 2017 between **Sponsor Name**, (hereinafter called "Sponsor") and the **Chiangmai Expats Club** (hereinafter called "CEC") in which both parties agree as follows;

1. In consideration of this Agreement the Sponsor shall pay (Select one option and delete the other.)
 - a. The sum of 1,500 THB to Sponsor the CEC for six months.
 - b. The sum of 3,000 THB to Sponsor the CEC for twelve months.

Depending on the timing of this Agreement, the sponsorship payment will be prorated accordingly. (See Articles 2 and 4 below).

2. The CEC agrees to provide the benefits from this Sponsorship Agreement from **start date** to **end date**, as stated below;
 - a. The Sponsor logo shall be displayed on the CEC Website Home page, with link to the Sponsor's website.
 - b. Sponsor Logo and description shall be placed on the CEC website's 'Sponsor Page', with Sponsor address, phone number and link to Sponsor website and Facebook page.
 - c. CEC shall give the Sponsor prominent acknowledgement at all CEC events.
 - d. The CEC shall arrange with the meeting venue, to provide a space with table(s) and chairs, for the Sponsor, in the foyer for the General Meetings, where Sponsors may display promotional literature and/or provide services to the CEC members.
 - e. The CEC shall allow the following;
 - 1)The ability to announce special events at General Meetings, upon prior approval by the Sponsor Committee chair.
 - 2)The ability to place special promotions on the CEC Facebook page.
 - 3)The ability to promote special events as part of a CEC email sent to its email list announcing upcoming CEC meetings.
3. The Sponsor agrees to the following;
 - a. Sponsor representative shall be a Life Member of the CEC.
 - b. To help provide valuable services and information to CEC members.
 - c. To help promote CEC meetings and other activities of the club.
 - d. Sponsor may provide a company Logoed placard, (60 cm x 60 cm) on a double-sided board, with a corrugated layer in between, made of plastic, such as 'Corflute' or a like material, which can be easily mounted to a wall. This logo will be prominently displayed on the wall during General Meetings. The cost of producing and/or replacing the logoed placard is the sole responsibility of the Sponsor. The Completed placard is to be delivered to the front desk of the Le Meridien CM Hotel at least one week prior to the next scheduled General Meeting. Sponsor shall notify the Sponsor Manager after the placard has been delivered.

- e. In addition to the logo, Sponsor to provide the exact wording required for the brief description to be posted on the CEC website including the correct website link for the company.
 - f. Sponsors will provide advertising and/or informative material for the club.
 - g. Sponsors are solely responsible for the legality of the products, services and or activities provided to the CEC or its members. CEC assumes no responsibility for any products, services or activities provided by the sponsor.
 - h. Sponsor shall email news of activities, within their organization, that may be of interest to CEC members. These announcements may be considered for inclusion in articles published in the CEC e-Newsletter and Facebook page. Text for these announcements should be sent to the CEC via email. The announcements shall be in a Word format and artwork shall be in JPEG or PNG format. Posting to the newsletter and/or Facebook is via a cut and paste process. **Minor editing of Sponsor-provided material may be provided, but not guaranteed.**
 - i. Sponsor may display their products and/or services but may not sell these products, services, and/or event tickets, at club meetings without prior approval of the CEC Sponsor Manager, obtained in writing one week in advance of the meeting.
 - j. Sponsor shall not seek business by claiming their organization as an official representative or spokesperson for CEC. However, the Sponsor is encouraged to add to their brochures, website, etc. that they are a proud sponsor of the CEC.
 - k. Sponsor will not have exclusive promotional and advertising right at any CEC event. The CEC, at its sole discretion, shall determine which, Sponsors, Advertisers and others may participate in all CEC Events.
 - l. Sponsor shall not promote more than two products and/or services at any given CEC meeting or event, per this Agreement.
4. Payment of the said sum of **0,000 THB** shall be made in full not later than the **1st** day of **January or July** 2017 or in the case of a prorate payment the first day of the commencement of this agreement. Payment may be made in cash or as a direct deposit to the CEC bank account.
 5. It is agreed that all matters relating to the administration of the sponsorship shall remain the exclusive responsibility of the CEC.
 6. The Sponsor will be notified one month before the expiration of their sponsorship term. The Sponsor will then have one week to notify the CEC in writing if they wish to renew the Sponsorship and for what term. The CEC shall inform the Sponsor if their renewal request has been approved not less than two weeks before the end of their current sponsorship term. However, the CEC at its sole discretion may waive this time limit.
 7. This Agreement is renewable and can be extended upon mutual agreement of the parties. The extension can be confirmed via e-mail, provided that payment in full for the extended term has been received by the CEC.

8. The Sponsor at its discretion may terminate this Sponsorship Agreement at any time by providing written notice to the CEC; however, previously paid sponsorship fees are non-refundable.
9. The CEC retains the sole right to terminate this Sponsorship Agreement, without notice, should the CEC Board determine, at its sole and absolute discretion, that the Sponsor has or may cause discredit or disrepute to the CEC. In this case, the CEC will refund to the Sponsor, any prorated unearned portion of the sponsorship fees already paid.
10. This Agreement is made solely between the CEC and the Sponsor and shall not be assigned, except with prior written consent of the CEC.
11. Changes may be made during the term of this Agreement only with mutual written consent of the parties.
12. The Sponsor and the CEC intend that this agreement; represents the final expression of the parties' intent and agreement between the parties relating to the subject matter of this agreement, contains all the terms the parties agreed to relating to the subject matter, and replaces all the parties' previous discussions, understandings, and agreements relating to the subject matter.
